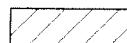

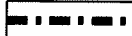

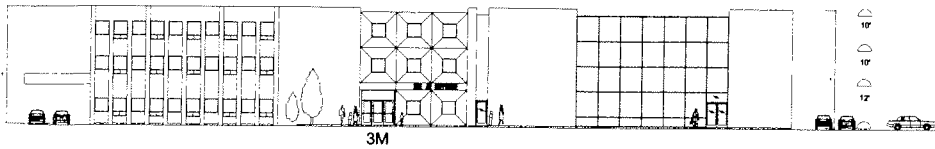

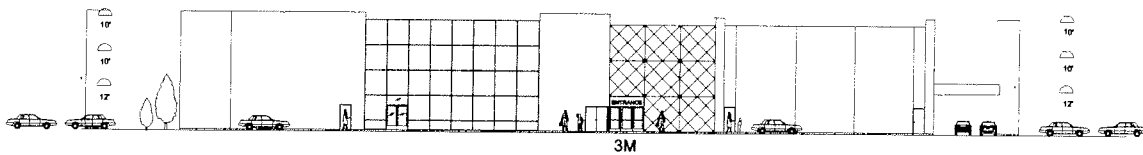

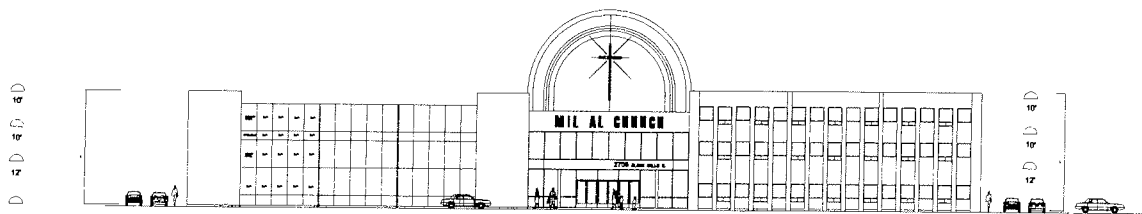

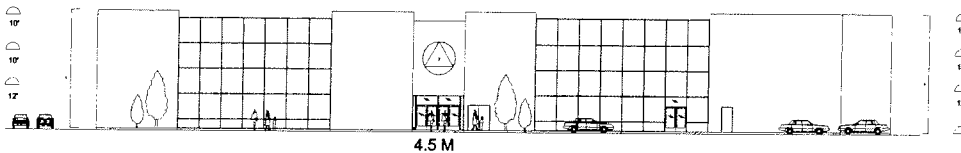
Ⓐ EAST ELEVATION

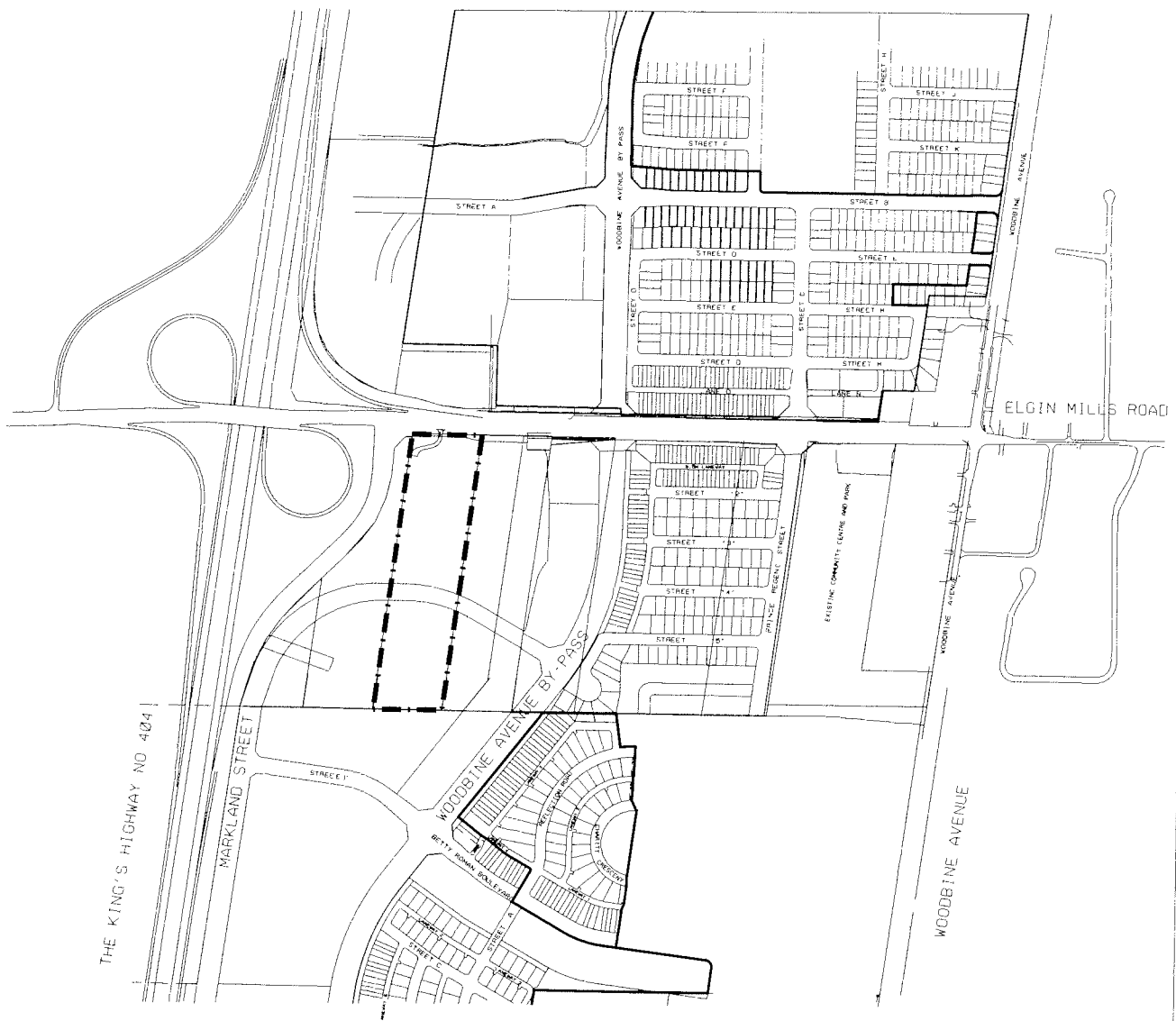

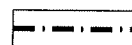
