strong community unity that followed the public meeting.

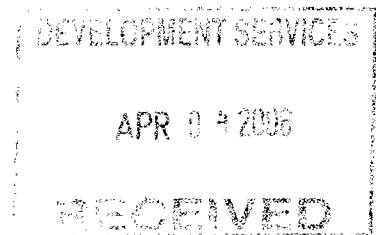
The petition attached for the Commissions review includes 32 neighboring households.
