# LANDS AFFECTED

The proposed By-law amendment applies to an approximately 75 m<sup>2</sup> (807 ft<sup>2</sup>) parcel of land, which forms part of a lot municipally known as 49 Colchester Street, located at the southeast corner of Gas Lamp Lane and Colchester Street.

#### **EXISTING ZONING**

The lands subject to this By-law are presently zoned Agricultural One (A1) under By-law 304-87, as amended.

# **PURPOSE**

The purpose of this By-law is to delete the subject lands from By-law 304-87, as amended, so that the lands can be incorporated into the designated Residential Two, Special Exception 190 (R2\*190) area of By-law 177-96, as amended.

# **EFFECT OF BY-LAW**

The effect of this By-law is to rezone the subject lands so that the lands are zoned consistently with the rest of the property. A single-detached dwelling with rear lane access will be built on this Block in combination with Block 338, Plan 65M-3767.

THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:


