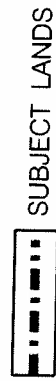

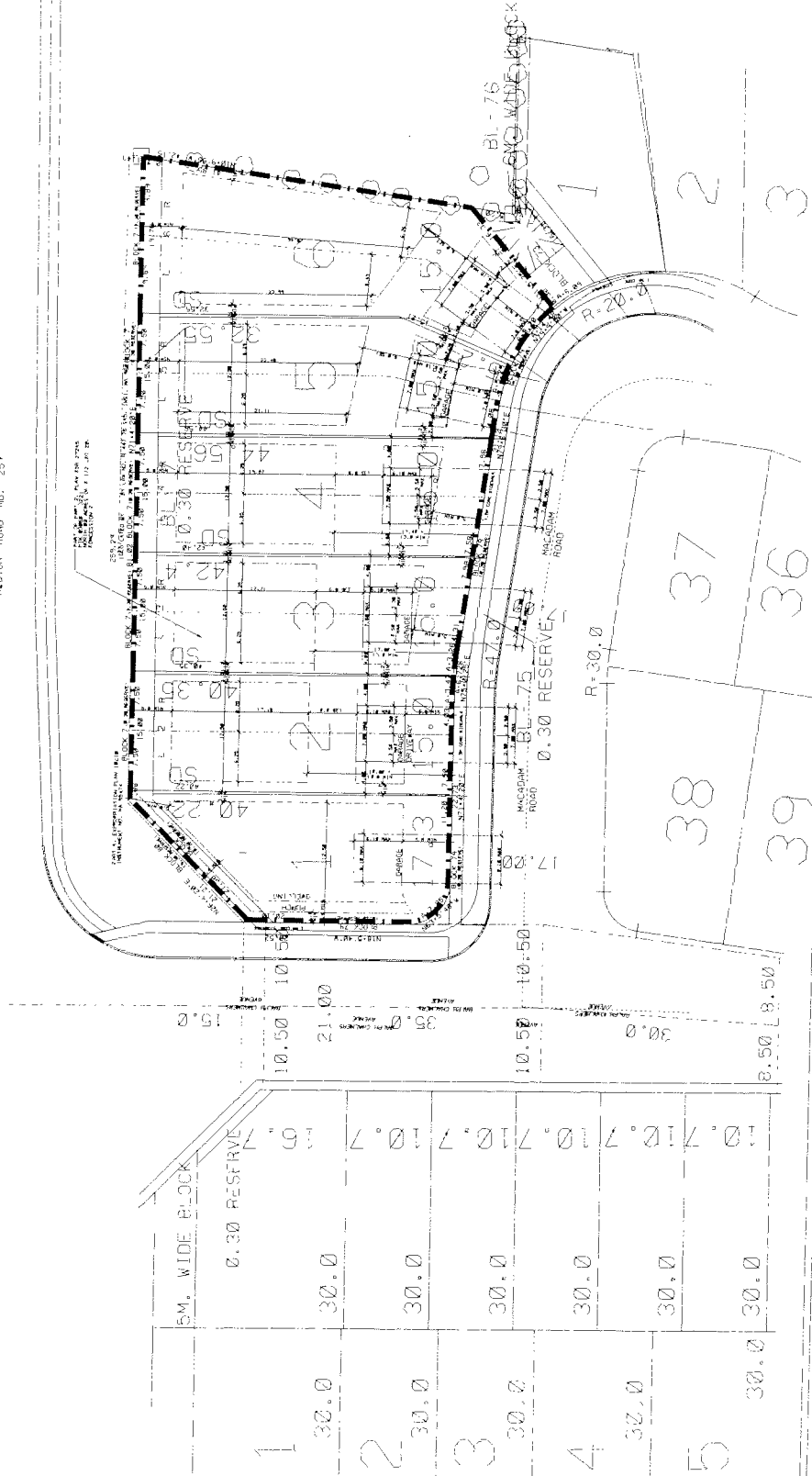

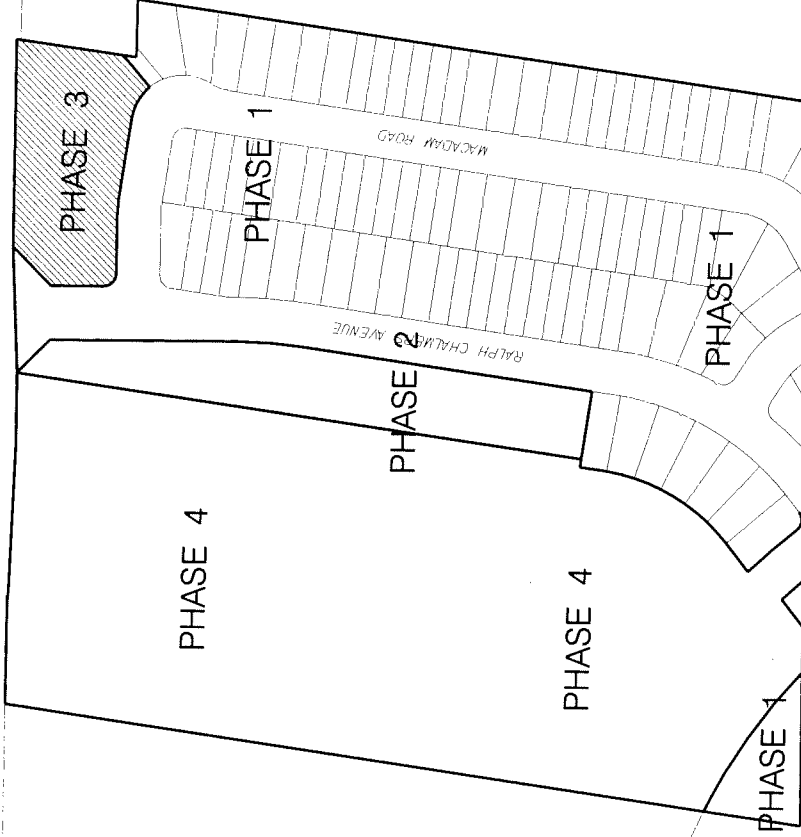

MAJOR MACKENZIE DRIVE EAST



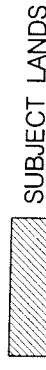
