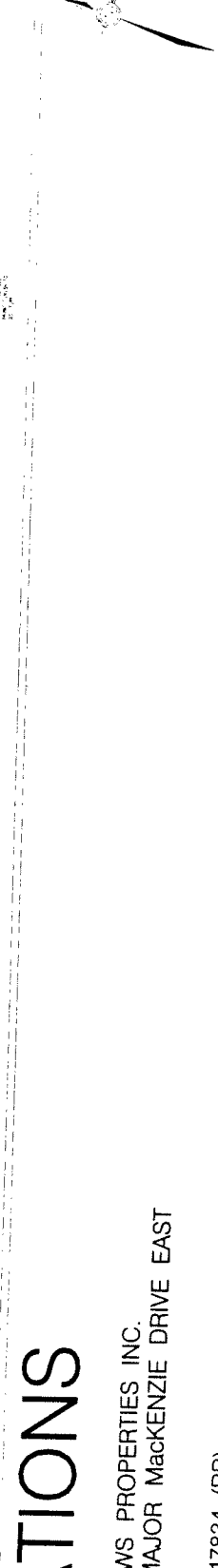
A1 SOUTH ELEVATION

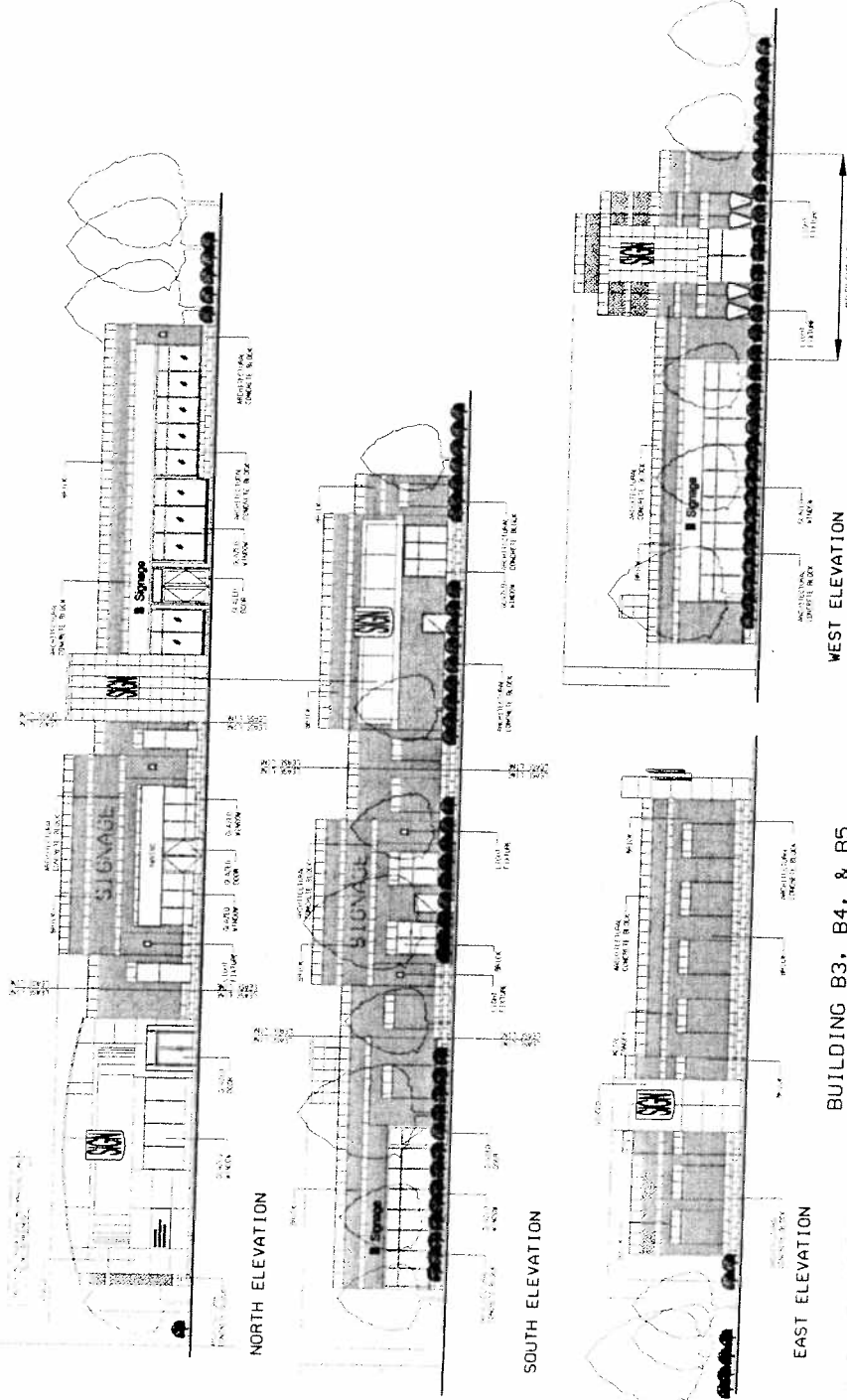

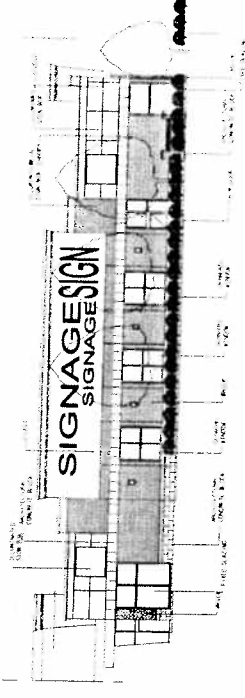
D1 NORTH ELEVATION

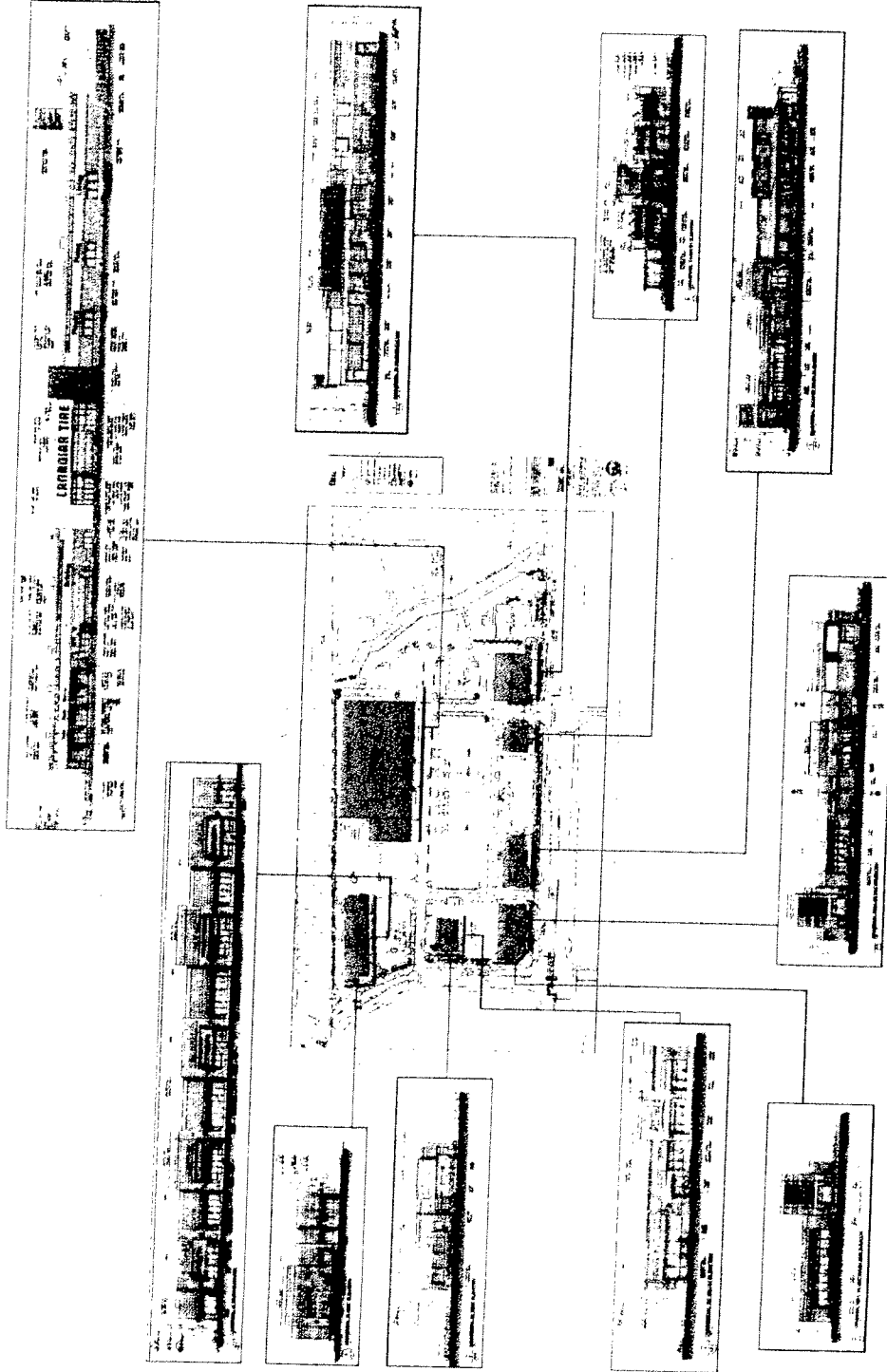
