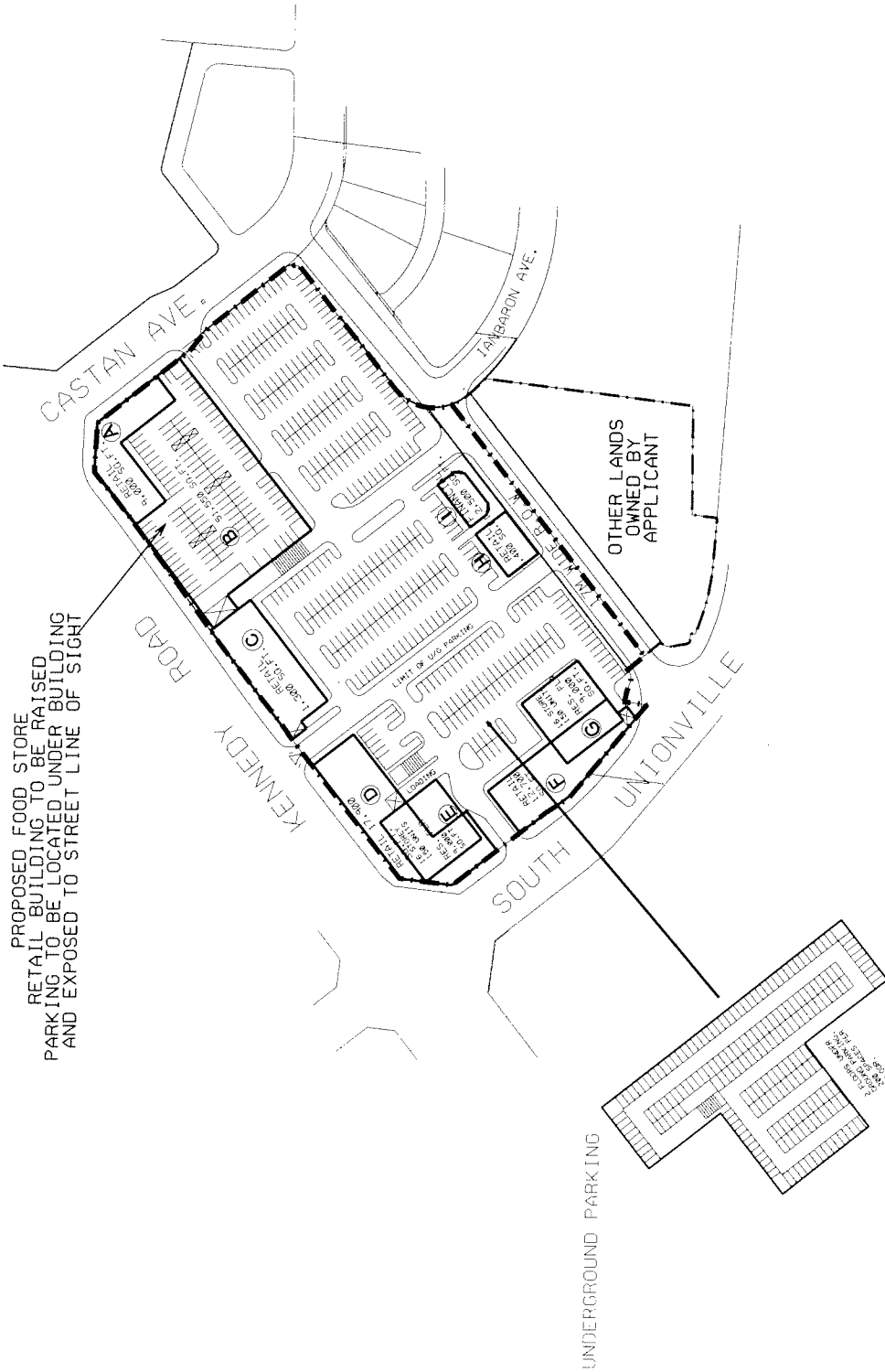

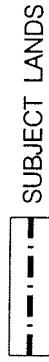
SITE PLAN

PARCEL FABRIC

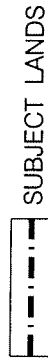

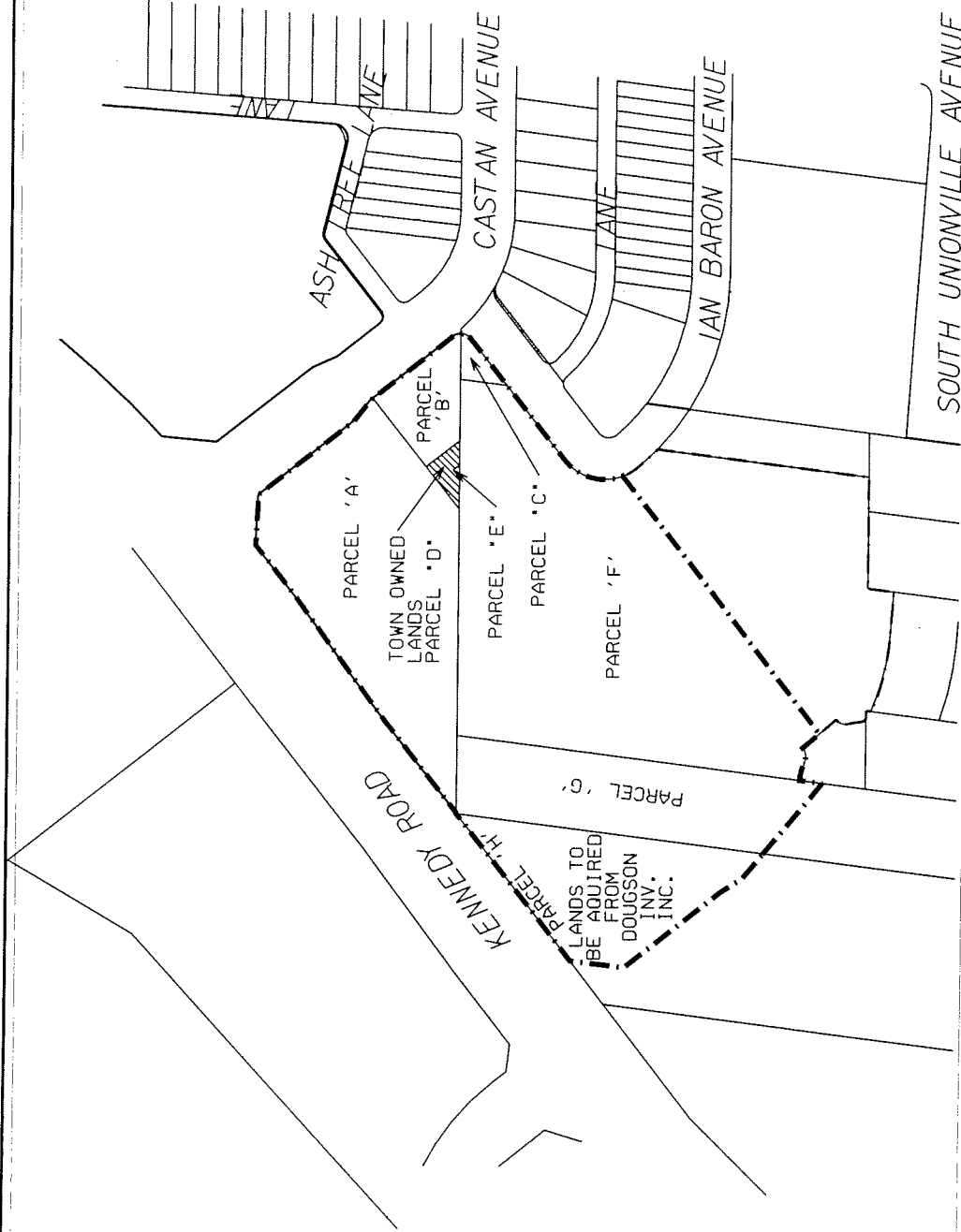

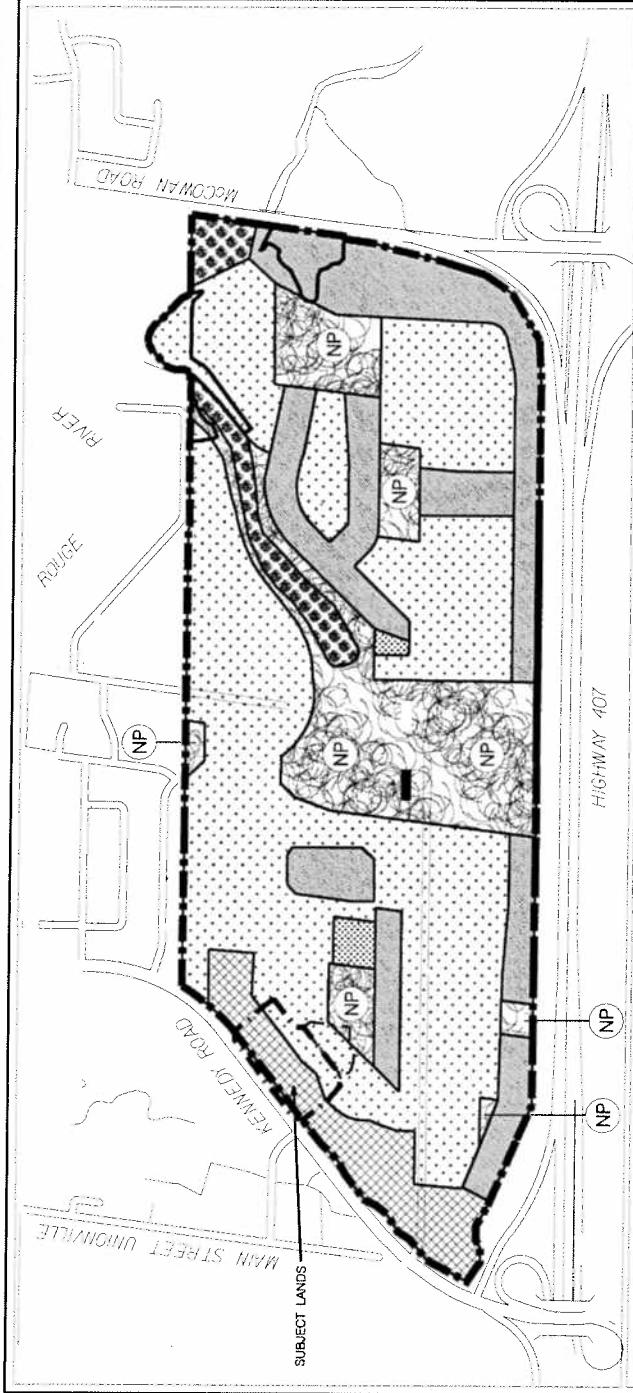
