



BY-LAW 2008-122

A by-law to amend By-law 2002-276 being a by-law to impose fees or charges for services or activities provided or done by the Town of Markham
(Community Services – Fire)

WHEREAS paragraph 391(a) of the Municipal Act, 2001, S.O. 2001, c.25 authorizes municipalities to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:

1. That Schedule “A” of By-law 2002-276, being a by-law to impose fees or charges for services or activities provided or done by the Town of Markham be amended as follows:

Increase the following amount to \$91.00 each to “Community Services – Fire”:

“Request a Fire Report” \$75.00 each

Increase the following amounts to \$145.00 each to “Community Services – Fire Inspection & Fire Prevention Fees”:

Residential requests:

mortgage clearance	\$100.00 per request
change of ownership	\$100.00 per request

Request inspections for premises/buildings:

a) Single occupancy	\$100.00 per request
b) Multiple occupancy	\$100.00 per request
c) Multi-storey building	\$100.00 per request

Requests for LLBO Licenses:

a) Premises	\$100.00
b) Patios	\$100.00
c) Special Occasions	\$100.00

Licenses for Day Care -

Day Nurseries/Home Care	\$100.00

3. That all other provisions of By-law 2002-276, except as herein amended, which are inconsistent with the provisions of this By-law shall continue to apply.
