
















Existing 2 storey office building looking north from Highway 7 E. (To be demolished)





Appendix 'A'

Site Plan Conditions

- 1. THAT site plan approval be delegated to the Director of Planning & Urban Design or her designate, to be issued following the execution of a site plan agreement. Site plan approval shall be issued only when the Director has signed the site plan "approved".
- 2. THAT the owner enter into a site plan agreement with the Town for the three proposed one storey detached commercial buildings at 5954-5956 Highway 7 E. containing all standard and special provisions and requirements of Town departments and public agencies;
- 3. AND THAT the site plan agreement make previsions for the payment by the applicant of all applicable fees, recoveries, and development charges;
- 4. AND THAT Heritage section Staff be given authority to approve the final architectural details of the three proposed new buildings and the restoration plan of No. 8 Markham Main St.
- 5. AND THAT prior to the execution of the site plan agreement, the owner shall submit final drawings which comply with all the requirements of the Town and authorized public agencies to the satisfaction of the Commissioner of Development Services;
- 6. AND THAT prior to the execution of the site plan agreement, the Owner shall submit a Landscape Plan, prepared by a Landscape Architect having O.A.L.A. membership, to the satisfaction of the Commissioner of Development Services;
- 7. AND THAT the site plan approval shall lapse after a period of (3) years commencing February 19, 2008 in the event that a site plan agreement is not executed within that period.

HERITAGE MARKHAM RECOMMENDS:

THAT Heritage Markham has no objection to the proposed redevelopment of 5954 Highway 7 subject to the following refinements to the design concept;

THAT the following architectural elements of the proposed new buildings be addressed:

- the logical architectural use of wood and brick cladding;
- more historically appropriate treatment of masonry around window and door openings;
- more traditional configurations of storefronts and signage;
- more traditional detailing of rooflines and eaves;

THAT the heritage house located at 8 Main Street North be restored by:

- removing the paint from the brick;
- the addition of historically accurate wooden shutters;
- the recreation of an authentic Victorian verandah on Main St.;
