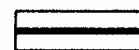

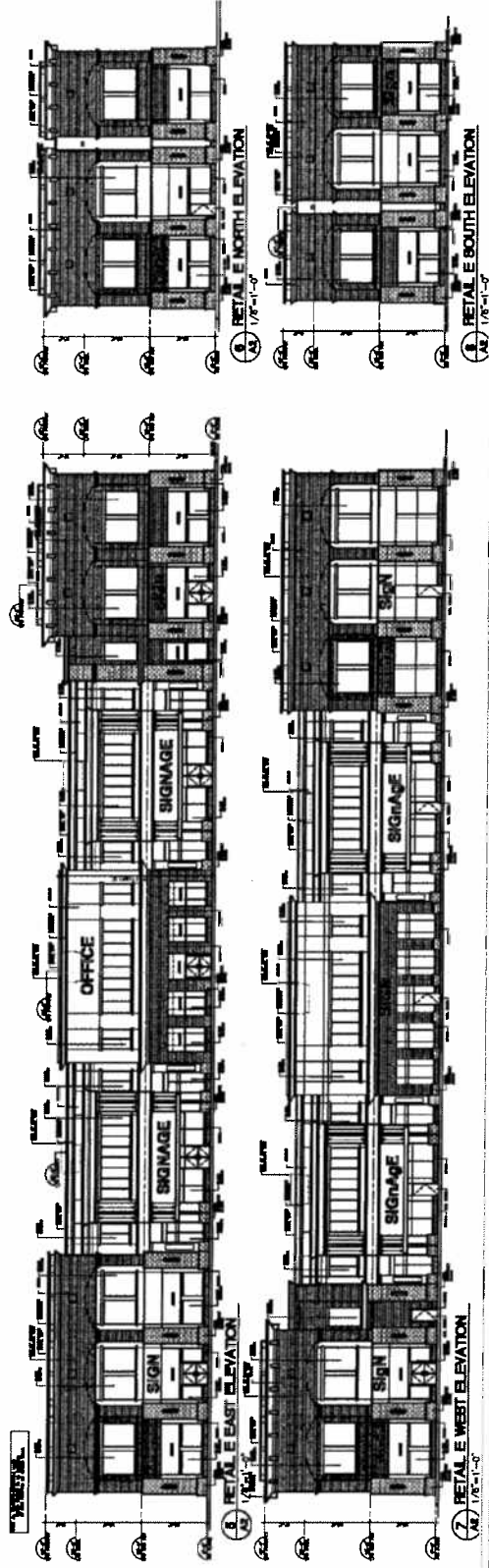

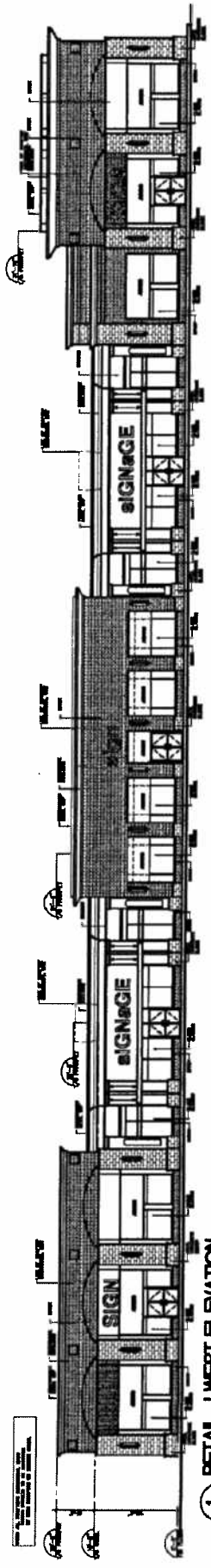

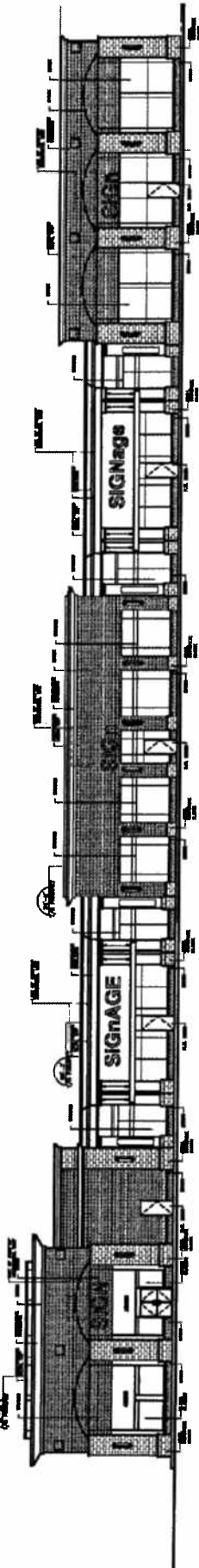

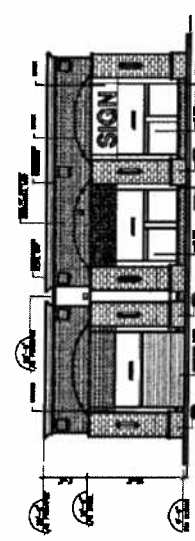

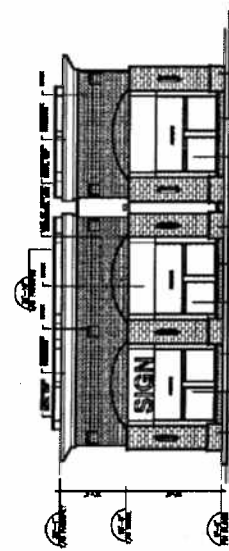
1 RETAIL J WEST ELEVATION
