Investing in Ontario Act, 2008

S.O. 2008, CHAPTER 6

Consolidation Period: From May 14, 2008 to the e-Laws currency date.

No Amendments.

Interpretation

1. (1) A word or expression that is defined in section 1 of the *Financial Administration Act* or section 1 of the *Fiscal Transparency and Accountability Act*, 2004 has the same meaning in this Act. 2008, c. 6, s. 1 (1).

Eligible recipient

(2) In this Act,

"eligible recipient" means a person or entity, other than an individual but including a partnership whose members may be individuals, that does not carry on activities for the purpose of gain or profit. 2008, c. 6, s. 1 (2).

Province's consolidated financial statements

(3) In this Act, a reference to the province's consolidated financial statements for a fiscal year is a reference to the summary financial statements set out in the Public Accounts for the fiscal year prepared in accordance with section 13 of the Ministry of Treasury and Economics Act. 2008, c. 6, s. 1 (3).

Authorized payments

2. (1) The Minister of Finance may, out of money appropriated therefor by the Legislature and in accordance with this Act and the regulations, make payments in respect of a fiscal year beginning on or after April 1, 2007 to eligible recipients on such terms and conditions as the Minister considers advisable. 2008, c. 6, s. 2 (1).

Maximum amount

- (2) The maximum amount that may be paid to eligible recipients under this Act in respect of a fiscal year shall not exceed the lesser of the amount appropriated by the Legislature for the purposes of this Act in respect of the fiscal year and the amount, if any, by which "A" exceeds "B", where,
- "A" is the amount that, but for the payments made under this Act in respect of the fiscal year, would be the surplus for the fiscal year as provided in the province's consolidated financial statements, and
- "B" is the amount, if any, prescribed in the regulations that represents the amount of the surplus referred to in "A" that is to be allocated to the reduction of the accumulated deficit. 2008, c. 6, s. 2 (2).

Regulations

- 3. (1) The Lieutenant Governor in Council may make regulations,
- (a) prescribing eligible recipients and classes of eligible recipients for the purposes of this Act;
- (b) prescribing the purposes for which payments may be made under this Act;
- (c) prescribing the method of and the basis for calculating payments to be made under this Act;
- (d) prescribing activities in which the Minister of Finance may engage in furtherance of the purposes of this Act;
- (e) prescribing, for the purposes of the definition of "B" in subsection 2 (2), the amount, if any, of the surplus for a fiscal year to be allocated to the reduction of the accumulated deficit shown in the province's consolidated financial statements for the fiscal year. 2008, c. 6, s. 3 (1).

Retroactive regulations

- (2) A regulation is, if it so provides, effective with reference to a period before it is filed. 2008, c. 6, s. 3 (2).

Investing in Ontario Act, 2008 Loi de 2008 permettant d'investir dans l'Ontario

ONTARIO REGULATION 277/08 PAYMENTS UNDER THE ACT IN RESPECT OF THE 2007-2008 FISCAL YEAR

Consolidation Period: From August 1, 2008 to the e-Laws currency date.

No amendments.

This Regulation is made in English only.

Interpretation

1. In this Regulation,

"available amount" means, in relation to any fiscal year of the province, the amount authorized to be paid to eligible recipients under subsection 2 (1) of the Act in respect of that fiscal year;

"preliminary surplus" means the amount that, but for the payments made under the Act in respect of a fiscal year, would be the surplus for the fiscal year as provided in the province's consolidated financial statements. O. Reg. 277/08, s. 1.

Allocation of preliminary surplus to reduction of accumulated deficit

- 2. For the purposes of the definition of "B" in subsection 2 (2) of the Act, the amount of the preliminary surplus in respect of the fiscal year commencing April 1, 2007 to be allocated to the reduction of the accumulated deficit shown in the province's consolidated financial statements shall be determined as follows:
 - 1. If the preliminary surplus is less than \$800,000,000, all of the preliminary surplus is to be allocated to the reduction of the accumulated deficit.
 - 2. If the preliminary surplus is greater than or equal to \$800,000,000 but less than or equal to \$2,600,000,000, \$600,000,000 of the preliminary surplus is to be allocated to the reduction of the accumulated deficit.
 - 3. If the preliminary surplus is greater than \$2,600,000,000, the amount of the preliminary surplus to be allocated to the reduction of the accumulated deficit is the sum of \$600,000,000 plus the amount of the preliminary surplus in excess of \$2,600,000,000. O. Reg. 277/08, s. 2.

Eligible recipients

3. Every municipality in Ontario is an eligible recipient in respect of the fiscal year commencing April 1, 2007. O. Reg. 277/08, s. 3.

Eligible purposes

- 4. Payments made under the Act, if any, in respect of the fiscal year commencing April 1, 2007,
- (a) may only be used by an eligible recipient for expenditures that are capital expenditures with respect to the eligible recipient under generally accepted accounting principles for local governments as recommended, from time to time, by the Public Sector Accounting Board of the Canadian Institute of Chartered Accountants; and
- (b) shall not be used for the purpose of reducing or paying out the amount of any debt relating to a capital expenditure if the debt was incurred by the eligible recipient before the date on which the relevant payment is received. O. Reg. 277/08, s. 4.

Method of and basis for allocations to eligible recipients

5. (1) In this section,

"municipal group" means a group of municipalities consisting of a municipality that as of March 31, 2008 is an upper-tier municipality and every municipality that as of March 31, 2008 is a lower-tier municipality that forms part of the upper-tier municipality for municipal purposes;

"population" means, in respect of an eligible recipient that is a lower-tier municipality, single-tier municipality or upper-tier municipality, the 2006 Census of Population census subdivision population that falls within the boundaries of the eligible recipient, as reported by Statistics Canada under the Statistics Act (Canada) as of March 31, 2008;

- "total population of all municipalities in Ontario" means the 2006 Census of Population census subdivision total population that falls within the boundaries of all single-tier municipalities and upper-tier municipalities in Ontario, as reported by Statistics Canada under the *Statistics Act* (Canada) as of March 31, 2008. O. Reg. 277/08, s. 5 (1).
- (2) The available amount for the fiscal year commencing on April 1, 2007 shall be allocated among eligible recipients as follows:
 - 1. The amount allocated to each eligible recipient that is a single-tier municipality as of March 31, 2008 and, subject to paragraphs 2 and 3, to each municipal group is calculated using the formula,

$A \times B/C$

in which,

- "A" is the available amount for the fiscal year,
- "B" is the population of the eligible recipient or of the upper-tier municipality of a particular municipal group, as the case may be, and
- "C" is the total population of all municipalities in Ontario.
- 2. From the amount allocated to a particular municipal group under paragraph 1, the amount allocated to the upper-tier municipality in the municipal group is calculated using the formula,

D×E/F

in which,

- "D" is the amount allocated to the municipal group under paragraph 1 for the fiscal year,
- "E" is the arithmetic mean of the capital expenditures reported in Column 07 (Capital Expenditures) of Row 9910 (Total) of Schedule 52 (Sources of Capital Fund Financing Expenditures) of the Financial Information Returns provided as of March 31, 2008 by the upper-tier municipality to the Ministry of Municipal Affairs and Housing for the years 2001 to 2005, and
- "F" is the arithmetic mean of the aggregate of all capital expenditures reported in Column 07 (Capital Expenditures) of Row 9910 (Total) of Schedule 52 (Sources of Capital Fund Financing Expenditures) of the Financial Information Returns provided as of March 31, 2008 by the upper-tier municipality and each lower-tier municipality that formed part of the upper-tier municipality for municipal purposes to the Ministry of Municipal Affairs and Housing for the years 2001 to 2005.
- 3. From the amount allocated to a particular municipal group under paragraph 1, the amount allocated to a particular lower-tier municipality in the municipal group is calculated using the formula,

$$(D-G) \times H/I$$

in which,

- "D" is the amount allocated to the municipal group under paragraph 1 for the fiscal year,
- "G" is the amount allocated to the upper-tier municipality in the municipal group under paragraph 2 for the fiscal year,
- "H" is the population of the lower-tier municipality, and
- "I" is the population of the upper-tier municipality in the municipal group.

- (3) The amounts of "E" and "F" referred to in paragraph 2 of subsection (2) may be obtained from the Ministry of Municipal Affairs and Housing. O. Reg. 277/08, s. 5 (3).

BACKGROUNDER: THE INVESTING IN ONTARIO ACT

THE INVESTING IN ONTARIO ACT

August 25, 2008

The provincial government is providing Ontario municipalities with \$1.1 billion in additional funding to support infrastructure investments through the *Investing in Ontario Act, 2008*.

In May 2008, the government passed the *Investing in Ontario Act*. The Act allows the government to use a portion of any unanticipated year-end surplus to address priority public needs as well as reduce the province's accumulated deficit.

Through regulation, the government designated municipalities as the eligible recipients of payments for 2007-08. Future eligible recipients will be identified based on provincial priorities.

The surplus for 2007-08 is sufficient to enable a payment under the *Investing in Ontario Act* of \$1.1 billion in additional funding to municipalities to support infrastructure investments while also reducing the province's accumulated deficit by \$600 million.

Prior to the passage of the Act, all year-end surpluses went towards reduction of the accumulated deficit.

MUNICIPAL ALLOCATIONS

Details on allocation amounts for individual municipalities and timing of payments are posted on the Ministry of Finance website.

The allocation is shared between municipalities primarily on a per-capita basis.

In instances where there are two levels of municipal government (e.g., counties or regions), the upper-tier municipality will share this amount with its lower-tier municipalities.

The upper-tier municipality will receive its share of funding based on its total municipal capital investments over the 2001 to 2005 period.

The lower-tier municipalities will receive the remaining amount on a per-capita basis.

While the funds are to be used for capital purposes, each municipality will have flexibility and discretion to spend its allocation on its own capital priorities such as improved roads and bridges, expanding transit or upgrading social housing.

ACCOUNTABILITY

municipalities will be subject to accountability requirements regarding their handling of payments received under the Act for the 2007-08 fiscal year including:

- Report-backs on how the funds were used
- The right of the province to independent verification or audit, and
- The right of the province to recover funds if they are not used for capital purposes.

SUPPORT FOR MUNICIPALITIES

In 2007-08, Ontario provided more than \$3.5 billion to municipalities for infrastructure, roughly double the amount provided in 2006-07. By redirecting a portion of provincial surpluses to municipalities this year for capital purposes, the Ontario government will further help to address the municipal infrastructure deficit and foster more job creation in the short term. These investments are evidence of a more collaborative and productive relationship between the province and Ontario's municipalities and represent another element of the government's five-point economic plan.

In 2007-08, Ontario invested a total of \$9.9 billion in infrastructure to improve the province's highways, public transit, municipal roads and bridges, hospitals, places to learn and other public assets. Investing in infrastructure is a crucial component of a strong economy and part of the government's five-point plan for jobs and growth in Ontario.

INVESTING IN ONTARIO ACT

All municipalities in Ontario will benefit from infrastructure funding under the Investing In Ontario Act. The allocation is shared among all municipalities, primarily on a per capita basis based on their 2006 census population.

In some areas of the province, there are two levels of municipal government (e.g. upper tier municipalities such as regions and counties and lower tier cities and towns), that share responsibility for municipal services. The per capita allocation for these areas will be shared between the upper-tier and lower tier municipalities.

The degree of responsibility for infrastructure investment between the upper and lower tier municipalities varies considerably across the province. To achieve a fair allocation between an upper tier and its lower tier municipalities, the upper-tier municipality will receive its share of funding based on its share of the total municipal capital investments in the area over the 2001 to 2005 period. The lower-tier municipalities will share the remaining amount on a per-capita basis. The investment data is submitted by all municipalities to the Ministry of Municipal Affairs and Housing and maintained in their Financial Information Return database.



Important Infrastructure Funding Announcements at 2008 AMO Conference

Issue: Two key announcements were made at the 2008 AMO Conference in Ottawa: the announcement by the Government of Ontario of an additional \$1.1 Billion in infrastructure funding for municipalities; and the signing by Canada and Ontario of Communities Component agreement of the Building Canada Plan.

Investing In Ontario Announcement:

On Monday, August 25th, Premier McGuinty announced that all municipalities will receive the largest portion of the 2007-08 provincial budget surplus of \$1.7 billion. Under the *Investing in Ontario Act*, the first \$600 million of the 2007-08 provincial operating surplus is used to pay down provincial debt and the remainder, \$1.1 billion, is being distributed to all municipalities in Ontario on a per capita basis. The funding can be used for any municipal capital expenditure. The funding is expected to flow in the coming weeks. AMO has been working closely with the Government of Ontario to better understand Ontario's municipal infrastructure deficit as part of the on-going Provincial Municipal Fiscal and Service Delivery Review. Additional provincial investment in municipal infrastructure is an important outcome of this work. The Review's work continues and is expected to conclude with a consensus report this fall.

Building Canada Communities Component Announcement:

On August 26th, Canada and Ontario signed the Communities Component Agreement of the Building Canada Fund, which will flow more than \$724 million in infrastructure funding for 7 years to rural and small urban municipalities across Ontario. The first intake will be open for applications on September 12, 2008 with \$200 million in combined federal and provincial funding available. Receiving municipalities will also contribute one third of the project costs.

Eligible project categories include drinking and wastewater systems, public transit, green energy, disaster mitigation, solid waste management, culture, sport, connectivity, local roads and core national highways, short-sea shipping and shortline rail, local and regional airports, tourism or brownfield redevelopment.

Action: AMO welcomed these announcements as helpful to the overall infrastructure deficit. AMO, however, continues to advocate for stable, long-term, predictable infrastructure funding for Ontario's municipalities.
