

BY-LAW 2009-36

A by-law to amend By-law No. 2002-276, as amended, being a by-law to impose fees or charges for services or activities provided or done by the Town of Markham

WHEREAS section 391 of the *Municipal Act*, 2001, S.O. 2001, c. 25 authorizes a municipality to pass a by-law imposing fees or charges for services or activities provided by or done on behalf of it;

AND WHEREAS section 392 of the Municipal Act, 2001 stipulates that a municipality shall establish and maintain a list for public inspection indicating which of its services and activities and the use of which properties will be subject to fees and charges;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM ENACTS AS FOLLOWS:

1. That Schedule "A" of By-law No. 2002-276, as amended, be further amended as follows:
