BY-LAW 2009-193

A By-law to amend By-law 165-80, as amended

Peoples Christian Academy Block 4, Plan 65M-2409 245 Renfrew Drive

Lands Affected

The proposed by-law amendment applies to a 2.2 ha. (5.4 acres) property municipally known as 245 Renfrew Drive.

Existing Zoning

The property is presently zoned Select Industrial and Limited Commercial [MC (60%)] by Bylaw 165-80, as amended.

Purpose and Effect

The purpose of the by-law amendment is to add permitted uses (Private School and Nursery School) on the subject property and establish the required number of parking spaces for the additional permitted uses.

The effect of the by-law amendment is to allow for a private school and nursery school to operate in the existing building on the subject property.



BY-LAW 2009-193

A by-law to amend By-law 165-80, as amended

THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:

1. By-law 165-80, as amended, is hereby further amended by adding to Section 7 – Exceptions the following new subsection:

7.112 245 Renfrew Drive

Notwithstanding any other provision of this By-law, the provisions in this Section shall apply to those lands shown on Schedule 'A' attached to By-law 2009-193. All other provisions of this by-law, unless specifically modified/amended by this section, continue to apply to the lands subject to this Section.

7.112.1 Additional Permitted Uses

The following additional uses are permitted:

- a) SCHOOL, NURSERY
- b) SCHOOL, PRIVATE

7.112.2 Special Site Provisions

The following additional provisions apply to a PRIVATE SCHOOL:

- a) Maximum number of all classrooms 32
- b) Maximum number of nursery school classrooms 3
- c) Minimum number of elementary school classrooms 13


7.112.3 Special Parking Provisions

The following parking provisions apply:

- a) The required number of parking spaces for both a NURSERY SCHOOL and a PRIVATE SCHOOL that are located on the lands shown on Schedule 'A' attached to By-law 2009-193 114 parking spaces
- 2. All other provisions of By-law 165-80, as amended, not inconsistent with the provisions of this by-law shall continue to apply.
