The Legacy Community Ratepayers' Association requests that the Town of Markham, approve a bylaw restricting parking on Legacy Drive and Rouge Bank Drive adjacent to Legacy Park.

Since Legacy Park was completed by the developer, we have experienced increased traffic congestion due parking on both sides of the street by players and guests during baseball games on the two Legacy Park diamonds managed by the Town.

Attached please find our petition signed all available residents that are fully in favour of restricting parking to the Legacy Park side of these two roads. We have conducted separate petitions for each road.

We are further requesting the Town rezone these roads by late February so that adequate time can be allowed for notice be given you teams and clubs booking the Legacy Park Baseball diamonds, signs be erected by March 30th, and enforcement be arranged. Once approved, we will inform or residents of this changes and encourage them the comply with the new bylaw and aid as appropriate with notification for Town enforcement.
