





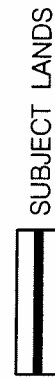

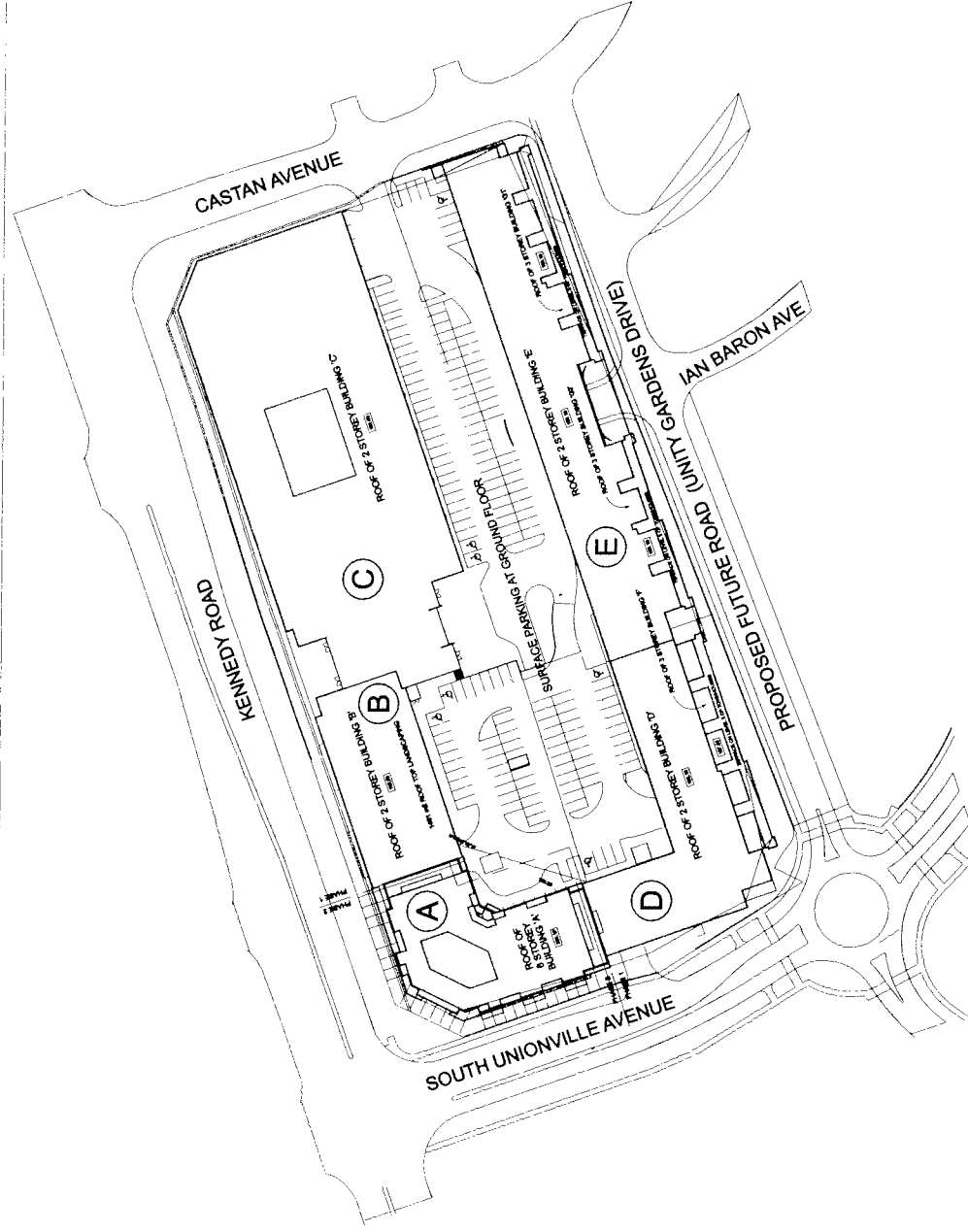

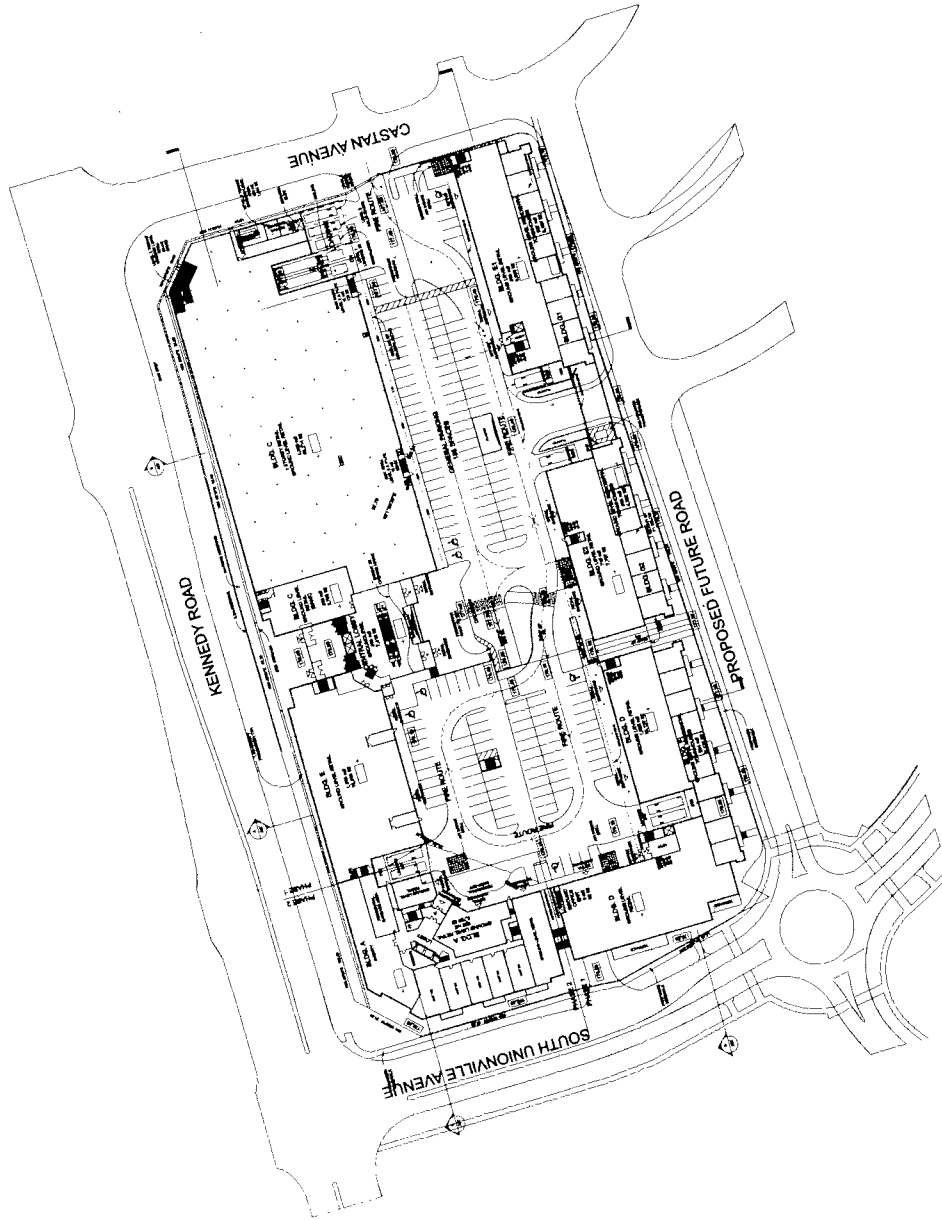

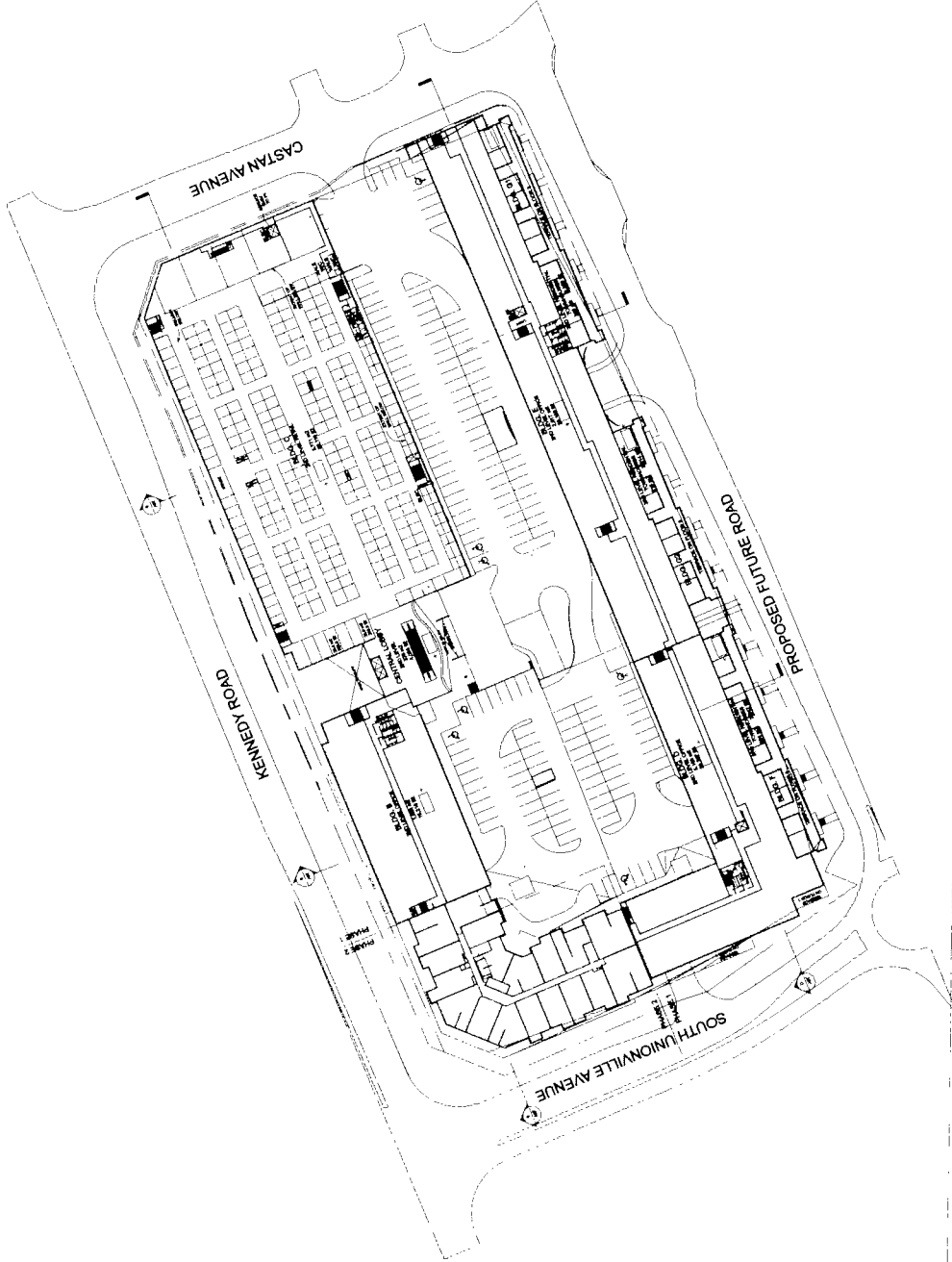

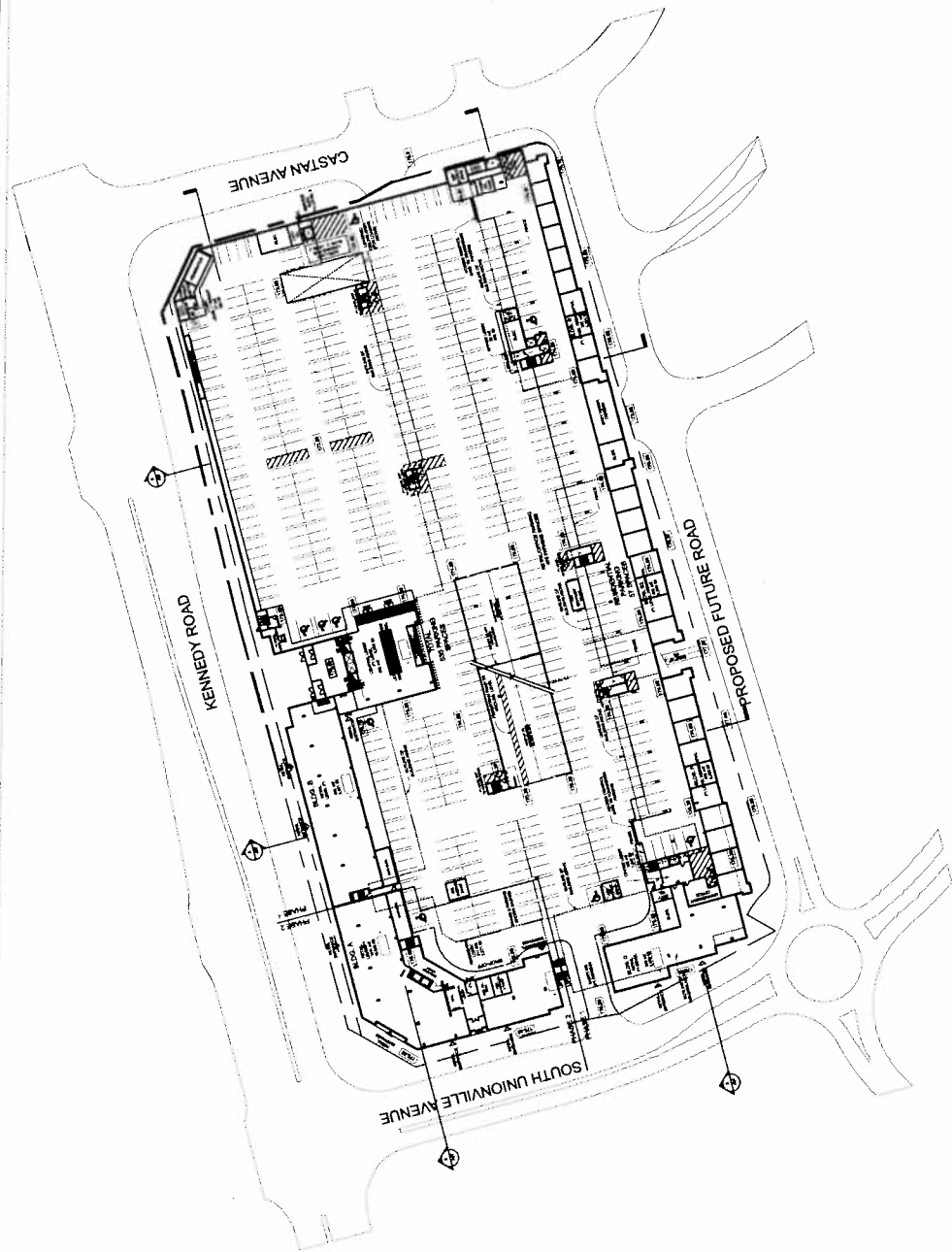

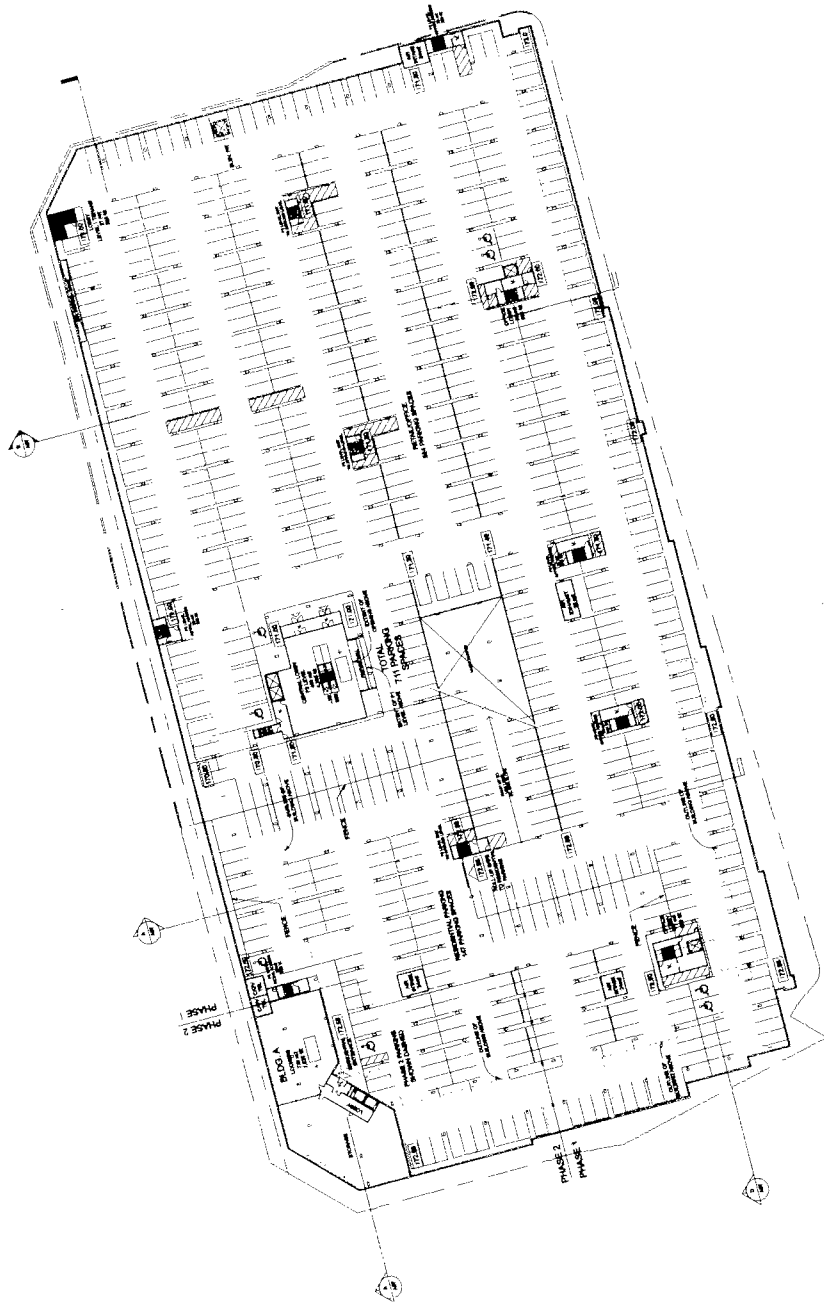

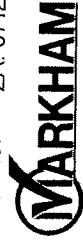

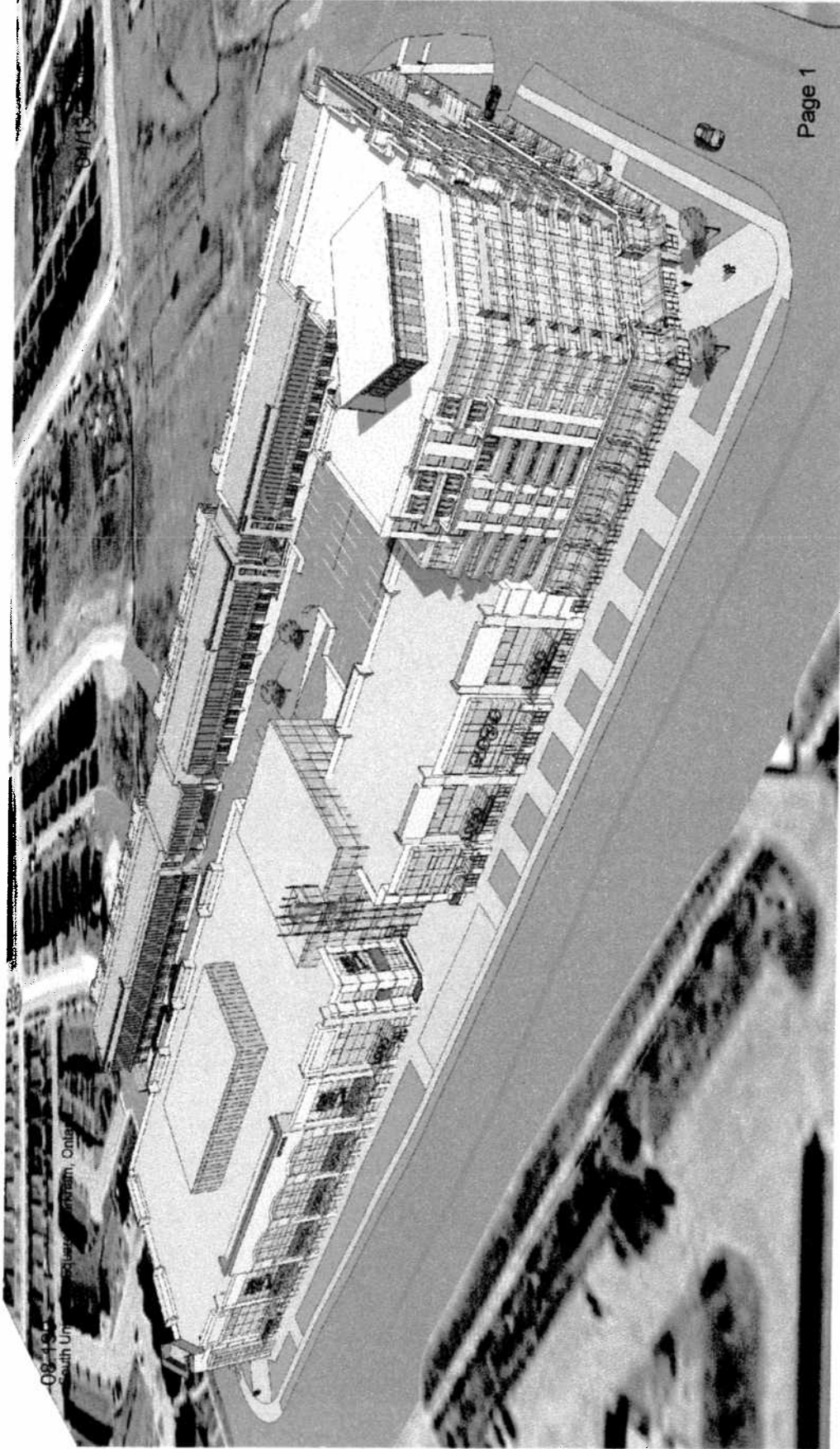

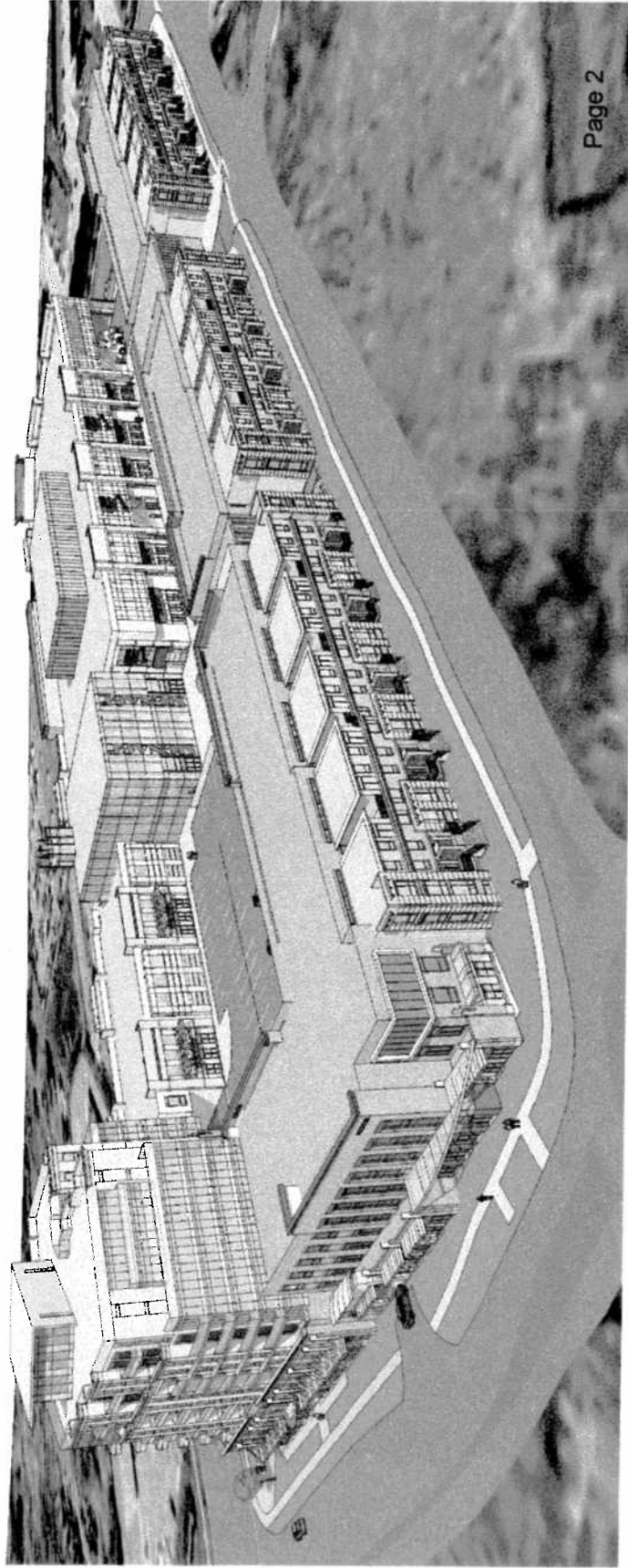

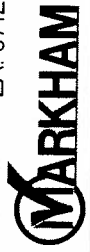


PERSPECTIVE FROM THE EAST

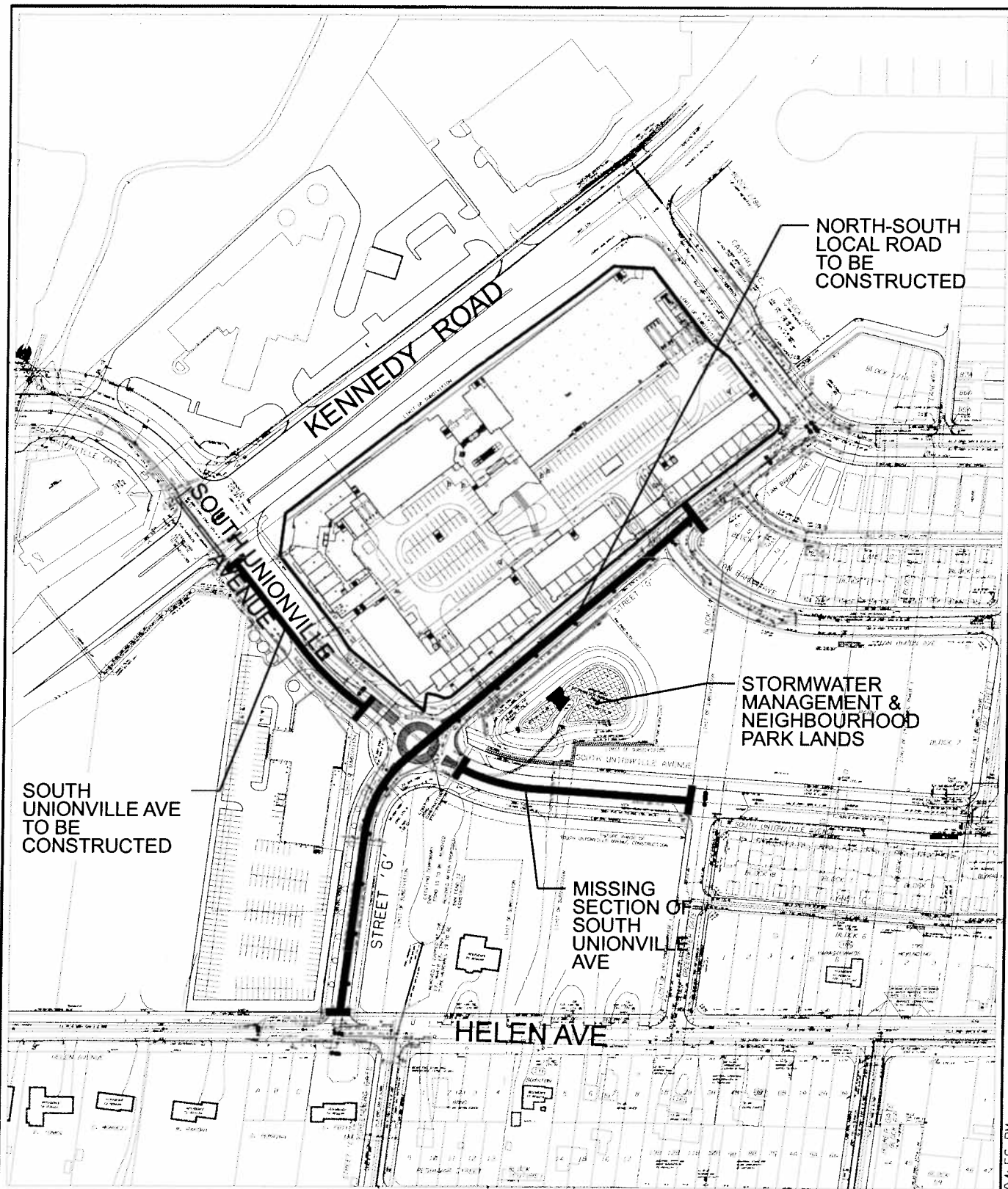
