I do hope tonight this committee will respect and take into account the wishes of the residents of Vinegar Hill. I have a petition and photographs proving the support of the residents of Vinegar Hill in regards to the demolishment of the dwelling situated on 15 Rouge Street. The residents of Vinegar Hill were very vocal and support the demolition because they feel that the current home situated on this property is not suitable for the community and is a complete eye sore.

This is a beautiful and prestigious community that would only benefit from a new dwelling of heritage design.

Within the last ten years Marconi Homes Ltd. completed many projects within the Heritage District in Markham.
