- **A.** E. Mariani Raised concern about recession and vacancies. Discussion ensued on role of Unionville by-laws in support of street. Others noted that high rents were a negative factor.
- **B.** E. Mariani Raised issue of fundraising for Christmas displays. Said he would initiate a fundraising program for Christmas decorations on Main Street.
- C. It was noted that our natural Christmas trees were all recycled through the Town mulching program.
- D. T. Lamanna Raised point of how terrible Unionville looked after Markham removed flowers last year. It was noted that these cuts were made and Town had already made flower purchases before meeting with the UBIA. Some members noted strong negative reaction from public who were surprised to see flowers removed from Unionville.
- **E.** UBIA is looking at alternative methods for addressing the shortfall created by the Town cutbacks in regards to flowers.
- **F.** Chair noted progress made on special tax areas in Toronto. Chair has been communicating with Toronto regarding creation of a similar special tax area for Unionville. Will follow up with proposal to Town to reduce tax burden on our members.
- **G.** Most members of the UBIA board were heading to the "Highway 7" meeting to oppose any change to the name Highway 7. Most members agreed that this was a waste of taxpayers' money and would negatively affect Unionville Tourism.
