

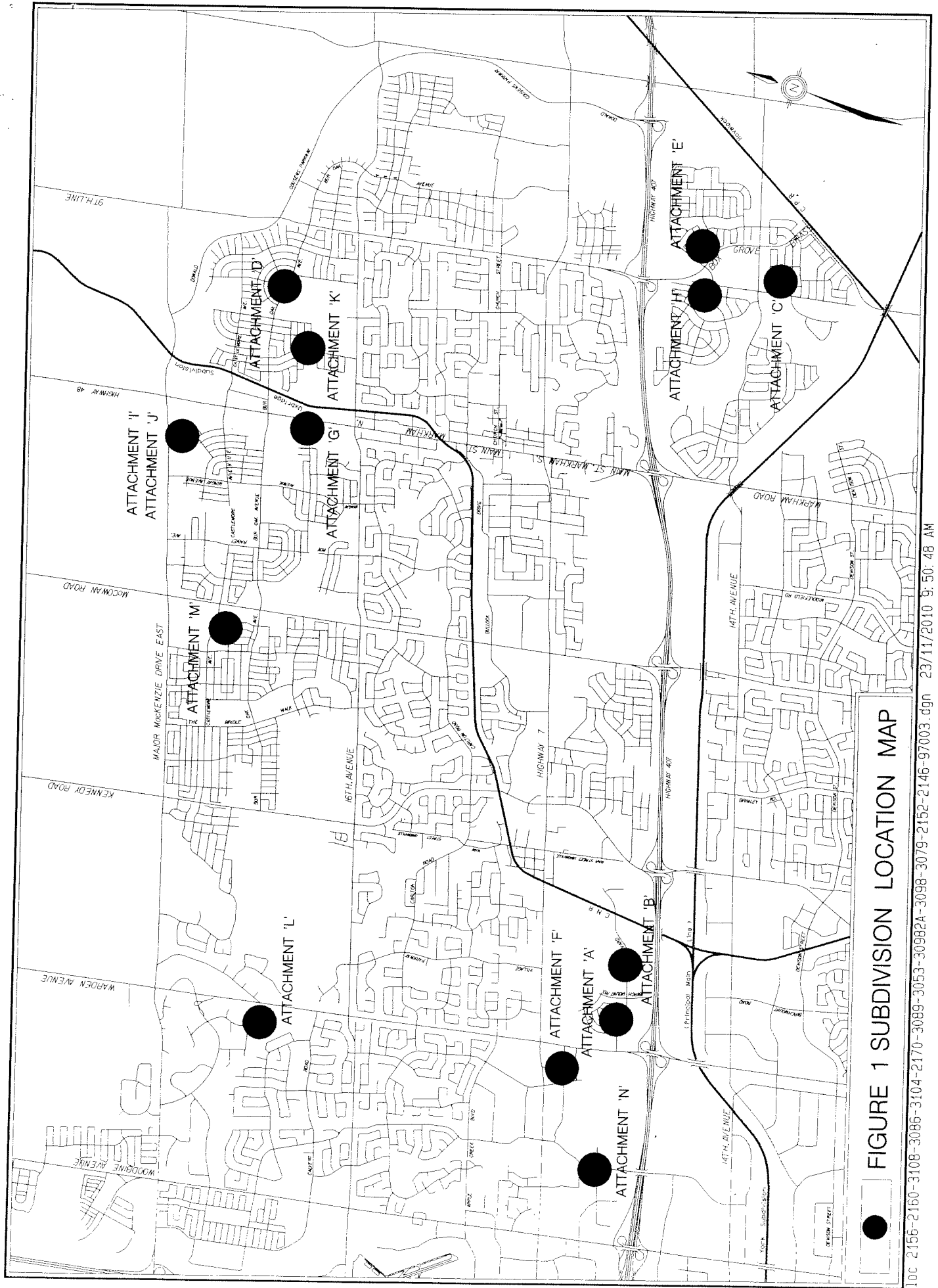
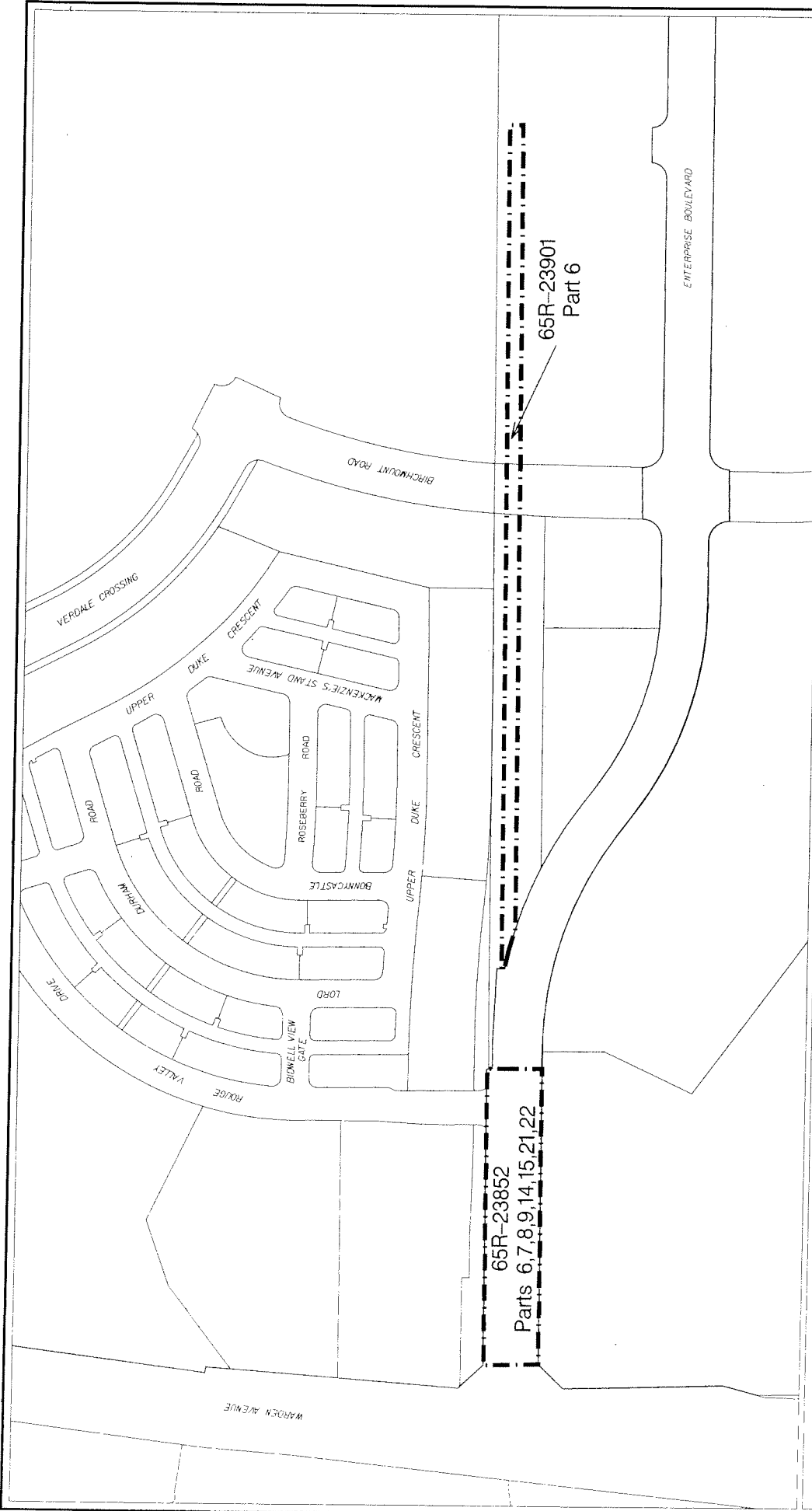



FIGURE 1 SUBDIVISION LOCATION MAP
