

BY-LAW 2012-48

A by-law to dedicate certain lands as part of the highways of the Town of Markham

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:

- 3. THAT Part of Block 122, Plan 65M-3397, designated as Part 23, Plan 65R-27219 Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named SOUTH UNIONVILLE AVENUE.
- 4. THAT Part of Lot 2, Plan 2196, designated as Parts 2 and 5, Plan 65R-31953, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named SOUTH UNIONVILLE AVENUE.
- 5. THAT Part of Block 15, Plan 65M-3756, designated as Part 7, Plan 65R-31953, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named SOUTH UNIONVILLE AVENUE.

- 11. THAT Part of Lot 1, Plan 2196, designated as Part 7, Plan 65R-30830, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named SOUTH UNIONVILLE DRIVE.
- 12. THAT Part of Lot 2, Plan 2196, designated as Part 14, Plan 65R-30830, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named UNITY GARDENS DRIVE.
