A by-law to dedicate certain lands as part of the highways of the City of Markham

The Corporation of the Town of Markham has changed its name to The Corporation of the City of Markham by By-law No. 2012-120 enacted and passed May 29, 2012, effective July 1, 2012, as evidenced in Instrument No. YR1847438 registered June 29, 2012.

WHEREAS Blocks 53 and 54, Plan 65M-4233 in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

AND WHEREAS Block 105, Plan 65M-4341 in the City of Markham, Regional Municipality of York was conveyed to The Corporation of the City of Markham for public use;

AND WHEREAS Blocks 115, 116, 117, 118, 119, 120, 121, 122 and 123, Plan 65M-3809 in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF MARKHAM HEREBY ENACTS AS FOLLOWS:

1. THAT Block 53, Plan 65M-4233, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named BEGONIA STREET.
2. THAT Block 54, Plan 65M-4233, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named FURROW STREET.
3. THAT Block 105, Plan 65M-4341, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named FURROW STREET.
4. THAT Block 115, Plan 65M-3809, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named GREENSPIRE AVENUE.
5. THAT Block 117, Plan 65M-3809, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named BEGONIA STREET.
6. THAT Block 119, Plan 65M-3809, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named HYACINTH STREET.
7. THAT Block 121, Plan 65M-3809, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named BEACON POINT STREET.

8. THAT Block 123, Plan 65M-3809, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named ROY RAINEY AVENUE.
9. THAT Blocks 116, 118, 120 and 122, Plan 65M-3809, City of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the City of Markham and named FRED MCLAREN BOULEVARD.
