Mobility Plus Deputation	<p>Kim McKinnon, Community Legal Worker, Community Legal Clinic and Sheri Upper, Regional Services Coordinator, York Region Spinal Cord Injury Ontario were in attendance representing the concerns of Concerned Citizens for Accessibility and Mobility Group, regarding York Region's proposed plans to outsource the Mobility Plus Eligibility Appeal Panel to Medisys Health Group.</p> <p>The following concerns were presented to the Committee regarding York Region's Plans to outsource the Mobility Plus Eligibility Appeal Panel:</p> <ul style="list-style-type: none">• The proposed changes to the panel have not been vetted through York Region's Advisory Committees on Accessibility.• The Report to York Region Council requesting this change did not include that in the event that an appeal cannot be heard within the designated timeframe prescribed by the <i>Accessibility for Ontarians with Disabilities Act</i>, compliance can be met by providing the rider with temporary ridership status until the appeal is heard.• That the Report to York Region Council did not make it mandatory for the members of the panel to be residents of York Region or for the panel to include a person with a disability.• The organization that the panel is being proposed to be outsourced to is a for profit organization that would be hired by York Region;• The transparency in the operations of the panel if outsourced to an external organization;• The high cost of outsourcing the panel and the use of taxpayer dollars.	<p>The Committee considered the information presented and was in support of the deputation.</p>
